recognizing outstanding staff

(11 June 2009, Hong Kong) NWS Holdings Limited (“NWS Holdings” or the “Group”, Hong Kong stock code: 659) held the NWS Awards Presentation Ceremony 2009 (the “Ceremony”) to recognize the achievements of employees with excellent performance.

The ceremony was held at the Hong Kong Convention and Exhibition Centre on 27 May 2009. Some 450 people, including the management of the Group and member companies, awardees and their family members, attended the Ceremony. Mr William Doo, Deputy Chairman of NWS Holdings, officiated at the Ceremony and remarked that the Group always perceives its staff as an important asset. Last but not least, NWS Sports Yearly Grand Award 2008 was also presented.
