NWS Holdings celebrates 15 years of corporate volunteering NWS Volunteer Alliance marks 150,000 hours of service to community causes

Since 2012, the Group has established a standing committee under the NWS Volunteer Alliance comprising some of the most experienced and enthusiastic volunteers. The committee suggests new ideas and seeks cooperation with non-profit organizations to drive the continued momentum of volunteerism.
